MIGRATIONPOLICY, GHAZI UNIVERSITY, DERA GHAZI KHAN.

PART-I. MIGRATION FROM GHAZI UNIVERSITY, DERA GHAZI KHAN TO OTHER INSTITUTIONS OF THE CITY/PUNJAB PROVINCE.

The students who got admission to Dera Ghazi Khan University and desire to migrate to another institution of the city or any university within the Punjab Province may be allowed to migrate on the following terms and conditions:

- i. The reasons for migration must be plausible.
- ii. The student will provide NOC of the institution where he wants to migrate.
- iii. The student will be required to clear all the University dues before he applies for migration.
- iv. The student will submit his request through the concerned HOD/Dean along with NOC of the institution concerned.
- v. The HOD/Dean will recommend the application to the Vice Chancellor for approval.
- vi. Once a student is allowed migration he will not be allowed to get back in the same degree course. However, he may get admission to any higher degree programme after completion of the degree for which he got permission for migration.
- vii. In case of a student who has been debarred from taking University examination or has been expelled or rusticated, for whatsoever reason, No Objection Certificate shall not be issued so far as the punishment is in force.

PART-II MIGRATION TO GHAZI UNIVERSITY, DERA GHAZI KHAN FROM OTHER UNIVERSITIES OF THE CITY/PUNJAB PROVINCE.

Normally, due to diversification of the courses and system of examination, it is difficult to entertain the request for migration. However, in case, the courses of study are identical, the students from other institutions of the city and province of the Punjab may be allowed to migrate to Ghazi University on the following terms and conditions:

- i. The reasons for migration must be plausible.
- ii. No student other than regular student shall be allowed admission by migration.
- iii. The applicant will provide "No Objection Certificate" and good moral character certificate to the effect that:-
 - (a) He has neither been debarred from taking University examinations or suspended nor expelled nor rusticated, for whatsoever reason, from the University or institution from which he intends to migrate.
 - (b) No disciplinary action is pending against him.
- iv. No student shall be admitted to first year and final year classes by migration.
- v. The applicant must fall within our admission merit of first semester of the year in which the applicant had sought admission at his parent institution.
- vi. No migration will be allowed to and from the constituent/affiliated institution
- vii. The applicant will provide detailed marks certificate/results of the semesters he passed from the parent institution.
- viii. No student shall be migrated to the University who carried any of his papers of previous years.

PART-III.MIGRATION TO GHAZI UNIVERSITY FROM VARIOUS PROVINCES OF THE COUNTRY

OTHER THAN PUNJAB PROVINCE.

- i. The reasons for migration must be genuine and plausible.
- ii. The applicant must fall within our admission merit of first semester of the year in which the applicant had sought admission at his parent institution.
- iii. No objection certificate by the parent institution and administrative departments of both the Provincial Governments.
- iv. Production of a certificate of good conduct and behavior from the parent institution to the effect that:
 - (a) He has neither been debarred from taking University examinations or suspended nor expelled nor rusticated, for whatsoever reason, from the University or institution from which he intends to migrate.
 - (b) No disciplinary action is pending against him.
- v. No student shall be admitted to first year and final year classes by migration.
- vi. Production of detail marks certificate of the courses studied by the applicant in the parent institution and syllabi of courses for equivalence of the courses.
- vii. The application along with above documents be routed through the administrative Department of the Institution and forwarded to the Punjab Higher Education Department, Government of the Punjab along with no objection for onward transmission to this University for consideration.
- viii. The request will be forwarded to the Migration Committee for making suitable recommendations.
- ix. The Standing Migration Committee after examining the request and the courses studied by the applicant in his parent institution will make suitable recommendation for consideration/approval by the Vice Chancellor.

PART-IV: STANDING MIGRATION COMMITTEE:

The Vice Chancellor will constitute a Standing Migration Committee of the University to recommend migration cases of all the above categories for his consideration/approval. Only the students of the institution having HEC chartered shall be considered for migration.
